## CST Annual General Meeting / Annual Elections / Annual Survey

*As you are aware, we normally hold our Annual General Meeting the weekend of the first League game of the season, produce the Annual Report in advance of that meeting and hold the online board elections immediately afterwards.*

*Because of the current uncertainties we are not sure what the implications of current and potential future restrictions will be in terms of whether we will be able to host a physical AGM in the foreseeable future and, if not, the logistics/limitations of a possible 'Zoom-style' meeting etc. We are talking to the Football Supporters Association (FSA) to identify best practise and will revert to you, our members, with more information when the situation is clearer.*

*Because our Annual Members Survey feeds into the AGM, again there is uncertainty as to the optimum time to hold that. The board are discussing the issue and, again, will notify members when a decision has been made.*

## Survey On Possible 'Project Restart' Options

*We have been involved, with other PL supporters trusts, in providing input to the FSA on 'Project Restart' and related issues, issues that affect all of us and that we all have opinions on. We are keen to identify supporter opinions on this complex issue and, to this end, plan to issue a short, sharp survey in the next few days.*

## 2019/20 Season Ticket Refunds and Munich Costs

### Season Tickets

*It seems clear that remaining 2019/20 PL games, if they take place, will do so behind closed doors. Given this, we are in discussion with the club on season ticket rebates and away season ticket rebates, and expect an announcement from them in the near future. Until there is more clarity about next season, and that clarity may be some way off, it is unlikely season tickets will be put on sale*

### Munich Travel / |Accommodation Costs

*The CST lobbied the club with regard to reimbursement for those who had incurred irrecoverable travel and accommodation costs for the cancelled Munich trip. It is pleasing that nearly 700 supporters have received, or will be getting, those costs back from the club.*

*In these times of so many difficulties for so many people, the CST board unanimously voted to release some funds for charitable donations. £250 were each given to the Stoll Foundation and the Hammersmith and Fulham Foodbank. A further £600 was donated equally to six member-nominated charities - Samaritans, Combat Stress, Princess Alice Hospice, Red Cross, Shelter, and the Chelsea FC Appeal for Refuge.*
